AREAS AND SUMMARY OF PRACTICE:

Since 1989 my practice has been concentrated on real estate transactions, real estate litigation and real estate development. For the past ten years, my office has closed an average of three to five residential transactions each week, and currently closes an average of three commercial transactions each month. I frequently review closing documents for residential real estate purchasers. I provide detailed comments concerning proposed real estate and business transactions, and assists purchasers and sellers in closing commercial and residential transactions.

From 1988 to 1989, I was a consultant for CSX Technologies working on the bid for the State of Florida SunBiz computer system.

From 1987 to 1988, I was the Vice President of Administration and General Counsel for Florida Digital Network, Inc., in Orlando, Florida. I worked with the sales, engineering and accounting staff in carrying out the day to day operations of the company, and assisted in developing the regulatory and long range plans of the company.

Between 1983 and 1987, I participated in a successful appeal to the US Supreme Court on behalf of the State of Alabama against the Federal Communications Commission, frequently participated in appeals to the Alabama Supreme Court on behalf of the Alabama Public Service Commission, and participated in multi-million dollars rate cases before the Alabama Public Service Commission, including electric companies, telephone companies, natural gas companies, and water utility companies.

From 1976 to 1983 I was a full time litigator in civil and criminal litigation, in State and Federal Courts. My civil practice was concentrated on personal injury actions, but included all types of civil litigation.
